1 WHAT IS SEIS/EIS?

- HAVE FEWER THAN 25 EMPLOYEES FOR SEIS OR FEWER THAN 250 FOR EIS
- NOT TO BE TRADING ON A RECOGNISED STOCK EXCHANGE AND NOT PLANNING TO
- BE ENGAGED IN A QUALIFYING TRADE
- NOT HAVE RAISED MORE THAN A CERTAIN AMOUNT (£ I 50,000 TOTAL FOR SEIS, £5 MILLION IN A YEAR FOR EIS

IT IS THEN REQUIRED TO UPDATE THE COMPANY STRUCTURE AND FILE THE CORRECT ACCOUNTS IN ORDER FOR THE BENEFIT TO TAKE AFFECT. THIS IS USUALLY DONE BY YOUR ACCOUNTANT AND THE PRICE MAY VARY.






CASE STUDY 1:

THEY QUALIFIED FOR THE ENTERPRISE INVESTMENT SCHEME (EIS) AND HIGHLIGHTED THE POTENTIAL TAX BENEFITS TO POTENTIAL INVESTORS. AN ANGEL INVESTOR, IMPRESSED BY THE COMPANY'S MISSION AND POTENTIAL IMPACT, WAS FURTHER INCENTIVISED BY THE TAX RELIEFS OFFERED THROUGH EIS. 

AN INTERESTED INVESTOR, SEEING THE POTENTIAL IN THE AI TECH, WAS FURTHER INCENTIVISED BY THE SUBSTANTIAL TAX RELIEF UNDER SEIS.
